

Privacy Policy

This **Privacy Policy** provides mandatory information as required under Art. 13 of the EU General Data Protection Regulation 2016/679 (GDPR), regarding the transparency of personal data processing.

The **Data Controller** connected with this Privacy Policy is Awm S.p.A. with registered office in Magnano in Riviera (UD), S.S. 13 Pontebbana, km 146, 33010.

1. Personal data collected.

The IT systems and software procedures used to operate the website acquire certain data referring to the User whose transmission is implicit in the use of the Internet communication protocols (navigation data). This data category includes: IP address, user name, password and connection URL as well as geographical position. On the other hand, other personal data, such as phone ID and email address can be explicitly provided by the user himself. In the use of certain Services of the Site (e.g. when filling in the "Contact Us" and "Careers" forms) there may be a processing of Personal Data of third parties. In this case, the user acts as autonomous data controller, assuming all the obligations and responsibilities required by law.

2. Personal data processing purposes:

- Anonymous statistical information regarding website usage
- Check of the correct functioning of the website
- Identification of anomalies and/or abuse
- Response to requests for assistance or information to users who have filled in the website forms
- Fulfillment of any legal, accounting and tax obligations

3. Mandatory or optional nature of data provision and consequence of any refusal

The provision of data is optional but necessary to provide the service. Refusal to provide the same will not allow provision of the service.

4. Data processors

Personal Data may be shared, for the above purposes, with:

- persons acting in their capacity as data controllers, namely, internal collaborators or professional firms providing commercial assistance and advice, or persons delegated to carry out maintenance or technical management of the site;
- persons, entities or authorities to whom it is compulsory to communicate the user's personal data pursuant to legal provisions or orders of the authorities;
- persons authorized by the Data Controller for activities strictly related to the provision of the Services or in any case for the sole purpose of responding to the user's requests, who are committed to confidentiality or have an adequate legal obligation of confidentiality.

The processing operations connected to the use of this Site take place at the headquarters of the Data Controller and only by authorised persons.

5. Transfer of Personal Data to Third Parties

The management and storage of personal data is controlled by the Data Controller and/or third party companies appointed as data processors, located within the European Union, in accordance with the provisions of art. 45 et seq. of GDPR. Currently the servers are located in Italy. The data provided will not be transferred outside the European Union.

6. Data retention period

The data collected and processed will be retained as long as necessary to comply with the Law and until the limitation period expiration.

7. Rights of the data subjects

Data subjects can exercise the right to access, rectification, erasure, restriction, portability, and also can object to or restrict the processing of personal data. Data subjects can also lodge a complaint with the personal data protection Authority.
